# **ALDS Privacy Policy**

ALDS ("we," "us," or "our") is committed to respecting your privacy and protecting the personal information you share with us, whether you visit our website (alds.com), shop in our online store, or interact with our services. This Privacy Policy explains how we collect, use, disclose, and safeguard your information. By using our website or services, you agree to the terms set out below.

1. Scope of Policy

This Privacy Policy applies to all personal information collected via our website, online store, and direct communications with ALDS. It does not extend to third-party websites or services we do not control.

2. Information We Collect

We may collect the following types of information:

- Contact Information: Name, email address, phone number, mailing address
- Payment Information: Credit card details and other payment methods for order processing

Data may be collected through direct input, cookies, logs, analytics services, and integrated third-party tools.

3. How We Collect Information

Personal information is collected when you:

- Submit inquiries via contact forms or email
- Automatically, via cookies, web analytics, and security systems

### 4. Use of Your Information

We use personal information to:

- Process and fulfill your orders
- Communicate about your account or transactions
- Send promotional materials (with your consent)
- Improve website functionality and services
- Comply with legal and regulatory obligations
- Prevent fraud and ensure website security

We will never sell, rent, or trade your personal information to third parties for marketing purposes.

Information is processed only for legitimate business purposes, with your consent, or as legally required.

### 5. Sharing of Personal Information

We may share your information with:

- Service Providers: Third parties for payment processing, shipping, IT support, and marketing, only as necessary to fulfill their services, and contractually bound to confidentiality and applicable privacy laws
- Legal Authorities: As required to comply with law or defend our rights
- Business Transfers: In cases of mergers, acquisitions, or company restructuring

Third parties must adhere to strict data protection standards.

## 6. Data Storage and Retention

Your personal information is securely stored on servers located in Canada and may be backed up by our hosting providers. Data is retained only as long as needed for business and legal purposes. When no longer required, personal data is securely deleted or anonymized.

### 7. Your Rights

You have the right to:

- Access: Request a copy of your personal data
- Correction: Amend inaccurate or incomplete information
- Withdrawal of Consent: Opt out of marketing communications at any time

- **Deletion:** Request deletion of your data (subject to legal/regulatory requirements)
- Complaint: Raise privacy concerns with our Privacy Officer or relevant authorities

### 8. Cookie Policy

Our website uses cookies for essential functions such as shopping cart operation and secure sign-in. Secure tokens are encrypted, cookie headers are enforced, and we do not use cookies for behavioral tracking or advertising. You may adjust your cookie preferences through your browser settings.

## 9. Analytics and Third-Party Tools

We use analytics tools (like Google Analytics) to understand site usage. These tools collect anonymized data, such as pages visited and device type. You may opt out via browser settings or Google's opt-out tool.

# 10. Data Security

We implement technical and organizational measures to protect your information:

- Encryption: Transmission of sensitive data via SSL/TLS
- Secure Payment Processing: WorldLine (Bambora) gateway uses PCI DSS-compliant tokenization
- Secure Shopping Cart: Ecwid platform is PCI-compliant with fraud prevention tools
- Access Controls: Restricted access and regularly updated security systems

#### 11. International Data Transfers

If personal information is transferred outside Canada (e.g., to third-party service providers), we ensure equivalent protection standards via PIPEDA-compliant contracts and safeguards.

You may:

- Update or delete account information by contacting us

- Adjust browser settings to reject non-essential cookies
- Request access to, correction, or deletion of your data at any time
